# What's in it for you?

You can list "starter" assets as an attractive reason for prospective clients to engage with your marketplace listing. As soon as the asset is downloaded, a new lead will be created for you in your marketplace lead console, offering you a new, potential sales opportunity.

#### **Data Services**

Data services for our customers to use and consume across FICO® Platform use cases. Partners can provide open API Spec File, or Postman Collection

#### Scorecards

We allow listing of scorecards generated and exported from an analytics environment for our customers to import and use in FICO Decision Modeler within FICO® Platform. We prefer partners provide PMML files for marketplace that users can directly import into decision modeler. However we will consider PDF files if they are detailed enough on how to build a given scorecard.

#### **Decision trees**

Decision trees for our customers to import and use in FICO Decision Modeler within FICO® Platform. Partners can provide either PMML or ISML files.

#### **Decision tables**

Decision tables for our customers to import and use in FICO Decision Modeler within FICO® Platform. Partners can provide CSV files.

#### Ruleset

Rule sets for our customers to import and use in FICO Decision Modeler within FICO® Platform. Partners can provide XLS files.

#### **Business Term Set**

We allow listing of business term sets for our customers to import and use in FICO Decision Modeler within FICO® Platform. Partners can provide XSD files.

## Submitting your API details

We will accept two options for submitting your API details for FICO® Marketplace listing

## OpenAPI Spec

- Preferred option
- One OpenAPI file per listing
- Spec 3.0+

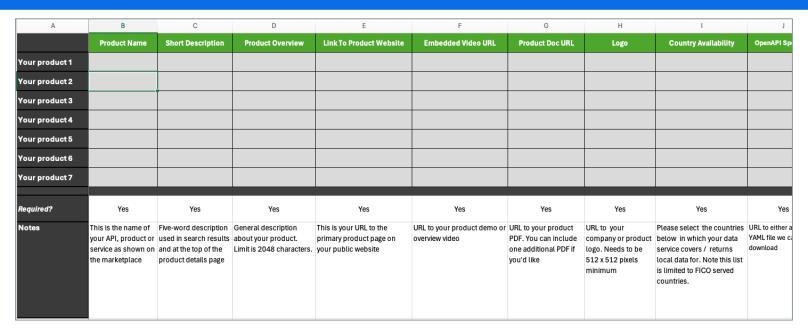
## **JSON Samples**

Endpoint URL (Server URL + path)

- Method type of the selected path (e.g., POST, GET)
- Sample request
- Sample response
- Authentication type as defined by the API specification's security scheme.
